

Credit for SMEs during 2018 By Tefta Demeti

According to the Bank of Albania, lending to the private sector has marked a moderate annual growth of about 2% on average in 2018, influenced by both still weak demand for private financing and careful lending policies of banks. As a ratio to GDP, the credit surplus for this sector is estimated at 35.2%, or about 1.2 percentage points lower than a year ago.

At the end of 2018, credit to small medium and enterprises accounted for about 9.0% of GDP. This level is slightly lower than that observed at the end of 2017, when this portfolio was 9.4%. This performance was affected by the stagnation in the loan portfolio for SME with an annual increase of 0.1%, as well as the significant increase in GDP during the year which is expected to be over 4%. A significant impact has been the strong appreciation of the lek against the currency and the continuation of clearing the balance of banks from the most problematic loans. The effect of the exchange rate on the SME loan portfolio is estimated to be around 4.2 pp. Adjusted for the exchange rate effect the credit growth for SME significantly improving compared to the real contraction that this portfolio marked a year ago. Compared to the end of 2017, the credit for small and medium business has increased by about ALL 5 billion, accounting for 36% have shifted from small business financing to credit for micro and medium-sized businesses.

The share of micro loans to total



of the annual credit growth for the private sector in SME credit - performance against GDP and structure by business size is given in the following figure.

According to the size of the portfolio business, the loan continues to be dominated by large business, which accounts for 53.8% of the total portfolio. SME loans account for 46.2% of the portfolio and their weight has increased by 1 pp compared to 2017. In particular, credit for micro businesses is the one that has given the main contribution to the expansion of the loan portfolio in 2018. The growth of this loan has balanced strong credit shrinkage marked 6.8% in December 2018, compared to 5% a year ago. According to the currency, it is noticed that the loan in lek has contributed positively to the expansion of the portfolio, while that in foreign currency has given a negative contribution influenced by the effect of the exchange rate. However, taking into account the appreciation of the lek, it is noticed that in the real growth of credit for SME - the main impact on the growth of 2018 has been given by foreign currency loans, mainly in euros, with about 75% of the total.

Entrepreneurs who are members of the Tirana Chamber of Commerce and Industry, held a meeting with the Prime Minister of the Republic of North Macedonia, Mr. Zoran Zajev and his cabinet. More than 40 representatives of Albanian companies were part of the meeting, held in Skopje, the first of its kind after Macedonia's new name.

SHGPAZ with 4 representatives of women's entrepreneurship was also part of this meeting.

In the economic forum Albania-Macedonia, in the afternoon of February 18, 2019, despite the negative experience I had from

ATA Carnet International Customs Document

ATA Carnet is an international customs document that allows the import of duty-free goods and taxes for a period of 1 year.

ATA Carnet is a perfect illustration of a close collaboration between business organizations and customs making it possible to facilitate international trade. This system is managed worldwide by World Federation the Chambers of Commerce. Each ATA Carnet member country has only one guarantor organization approved by the National Customs Authority "Word Chamber Federation" (WCF). The quaranteeing body enjoys the right to issue ATA Carnet and the authorization of local units to cooperate. In Albania, quarantor for approval by the WCF is the Union of Chambers of Industry of Commerce and Albania (UCCIA).

ATA Carnet in Albania

On December 18, 2012, the Cooperation Agreement between the General Directorate of Customs and the Union of Chambers of Commerce and Industry was signed, which defines the terms of cooperation between the two institutions for the implementation of ATA Carnet in Albania.

On February 25, 2013, ATA Carnet started operating in Albania.

In 2013 UCCIA became the 72-guarantor organization ICC WCF ATA. ATA Carnets will be accepted by the Albanian Customs Authority under the Convention on Temporary Permission WCO (Istanbul Convention, 26 June 1990).



ATA Carnet covers:

- Commercial samples
- Professional equipment
- Goods for use in trade fairs, exhibitions, etc.

ATA Carnet can be used in the following cases:

- Temporary permission related to goods to be displayed or used in exhibitions, fairs, meetings or similar events;
- Temporary permitting for containers, pallets, packaging, samples and other imported goods in connection with a commercial operation;
- Temporary permit for imported goods in connection with a processing operation;
- Temporary permit for imported goods for educational, scientific and cultural purposes;
- Temporary leave for personal

belongings of the traveler and imported goods for sports purposes;

- Temporary permit for tourist promotional materials;
- Temporary permit for imported goods such as border transport;
- Temporary permit for imported goods for humanitarian purposes;
- Temporary permit of spare parts and imported equipment for the repair of means of transport, which are temporarily allowed;
- Temporary permission for animals.

The draft law "On employment promotion"

The new draft on employment promotion aims to increase the employability of the workforce through the provision of public services and programs of and employment selfemployment, as well as vocational training. It defines the objectives and functions of the public system of employment services, active and passive labor market programs, vocational training and the institutions responsible for their management.

The draft law "On the promotion of employment" was drafted in order to reflect the changes and dynamics of the labor market, after a period of 23 years, since the adoption of the existing law (1995). Also, the draft law was drafted in the spirit of governing professional vision, where qualification and employment should be closely linked. The need to review current employment promotion policies and those of the qualification system, in the context of the inclusion of Vocational Education and Training (VET), was necessary.

The Government Program 2017 - 2021 has focused on employment and quality development of the workforce, in accordance with the vision and directives of the European Union, the European Employment Strategy 2020, as well as the requirements for Albania's European integration into the EU. The National Strategy for Employment and Skills 2014 -

2020 charges the system with tasks and activities related to labor market governance, active labor market programs, vocational education and training, etc. vocational training; training through work; selfemployment; support for new businesses and business incubators; job placement and reasonable adaptation; implementation of professional qualification support programs in dual form of VET: the employment of graduates / certified in vocational education professional and training; practices; youth quarantee social reintegration program; programs; transport to workplace; etc.

Also, the draft law provides other forms of support, both for public and private providers, to be financially supported for conducting courses for unemployed jobseekers, for professions required in the labor market, according the requirements followed by employment offices. This draft law provides for the establishment of the institution responsible for employment and training (today the National Employment Service), as a unit, which will collect in one and reconceptualize according to best practices the modernization of employment offices, service system employment, employment promotion programs and



the ability to improve skills throughout the life cycle.

The draft law regulates the regarding provisions the employment of persons with disabilities who have not found application in the existing law. In addition supporting to employment promotion programs, reasonable adjustments have been made to the issue of the obligation to employ people with disabilities employers. The draft law provides for the creation of the Social Employment Fund, in the form of public financial fund administered by the Fund's Board of Directors. The source of funding for the fund will be the contribution of employers who do not employ 1 person with disabilities for every 49 employees employed and in this case are obliged to pay a contribution on behalf of the Social Employment Fund, to the extent and 50% of the national minimum wage, for each month, for each person with a disability that he or she should have employed.

Women and Health Childhood cancer

Cancer is a malignant disease that affects all ages, and unfortunately does not spare even children. Leukemia is a form of cancer that mainly affects people over the age of 55, but it is also the most common form of cancer in pediatric ages. Leukemia is a tumor (cancer) of the blood cells. Blood elements are produced in the bone marrow. They are produced by passing from immature cells to well-differentiated ones, forming various cells with special functions. In leukemia, immature blood cells develop cancer. These cells cannot develop the function of blood cells, as they have a great ability to reproduce abnormally by occupying the bone marrow and inhibiting the further production of white blood cells, red blood cells and platelets. Leukemia can be acute or chronic, depending on the stages of its development. The acute form is a form that develops rapidly and also worsens rapidly. Chronic form is a form that develops and worsens more slowly. The treatment and progression of leukemia depends on the type of cell that has developed as well as on the acute or chronic form. Different types of leukemias depend on the type of blood cell developed.

What are the signs and symptoms of leukemia?

The symptoms of leukemia vary depending on the type of tumor, but some general signs include:

- •Temperature 37-38 ° C, fever
- Weakness, constant fatique
- Frequent recurrent and often severe infections

- Bone pain
- Enlargement of the lymphatic glands, enlargement of the spleen and liver
- Appearance of bruises on the body and bleeding easily
- Increased night sweats
- Significant weight loss

What are the factors that favor the development of leukemia?

Factors that increase the risk of developing certain types of leukemia are:

Genetic abnormalities.

Some genetic abnormalities, such as Down syndrome, are associated with a higher risk of developing leukemia in pediatric ages.

Exposure to certain chemicals, such as benzene, which is found in gasoline and used in the chemical industry, increases the risk of developing leukemia.

Smoking.

Family history of leukemia. If a family member has been diagnosed and treated with leukemia, then people with close blood relation are more at risk for developing leukemia.

Treatment for a previous cancer.

People who have received chemotherapy or radiotherapy to treat a cancer are at greater risk of developing various types of leukemia over time.

How is leukemia treated?

Leukemia is treated with chemotherapy and combined with supportive therapy. The goal of treatment is to achieve complete remission through chemotherapy, which includes eliminating abnormal clinical signs and restoring normal blood values. The complex nature of patients, clinical situations and the use of appropriate preparations according to standard therapeutic protocols require a specialized staff and this is why these patients should be treated in hematological centers. The presence of other diseases makes treatment of leukemia more difficult and individual therapy is done judging case by case and step by step.



Treatment

Cure is also the main goal of treating leukemia, especially when it comes to young children. Children and elderly usually have poor prognosis, especially those with irregular liver or kidney function, brain involvement, or high white blood cell count (> 25,000 / μ L). If left untreated, the course of acute leukemia usually lasts 3 to 6 months.

2004 and a year later by the Insafe Network, Safe Internet Day has grown beyond its traditional geographical area and is now celebrated in about 140 countries around the world. This year, International Safer Internet Day was held under the motto "Together for a more secure Internet" encouraging citizens to create a better internet through the development of four critical skills: Respect, Responsibility, Logic Response. It is also a call for action for the government, civil society, the internet industry, parents, teachers, etc., to protect and raise awareness of children adolescents from the dangers of online navigation.
